

## NOTICE OF PENDING BOND ORDINANCE AND SUMMARY

The bond ordinance, the summary terms of which are included herein, was introduced and passed upon first reading at a meeting of the governing body of the Borough of West Wildwood, in the County of Cape May, State of New Jersey, on April 2, 2026. It will be further considered for final passage, after public hearing thereon, at a meeting of the governing body to be held at the Borough Hall, 701 W. Glenwood Avenue, in the Borough on May 1, 2026 at 7:00 o'clock p.m. During the week prior to and up to and including the date of such meeting, copies of the full bond ordinance will be available at no cost and during regular business hours at the Clerk's office for the members of the general public who shall request the same. The summary of the terms of such bond ordinance follows:

Title: BOND ORDINANCE PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS IN AND BY THE BOROUGH OF WEST WILDWOOD, IN THE COUNTY OF CAPE MAY, NEW JERSEY, APPROPRIATING \$1,275,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$1,232,750 BONDS OR NOTES OF THE BOROUGH TO FINANCE PART OF THE COST THEREOF
