**ORDINANCE OF THE BOROUGH OF WILDWOOD CREST
AMENDING AND SUPPLEMENTING SECTION 79-32.3,
SCHEDULE IC, RESTRICTED PARKING ZONES FOR
PERSONS WITH DISABILITIES; SECTION 79-32.4, GOLF
CART PARKING; SECTION 79-3.1, RESTRICTED PARKING
HEATHER ROAD; REPEAL PORTION OF SECTION 79.3 OF
THE CODE OF THE BOROUGH OF WILDWOOD CREST**

WHEREAS, the Board of Commissioners of the Borough of Wildwood Crest has determined that it is necessary and proper for good government, order and the protection of persons and property, and for the preservation of the public health, safety and welfare of the Borough and its inhabitants to update, amend and supplement Section 79-32.3, Schedule IC, restricted parking zones for persons with disabilities.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of the Borough of Wildwood Crest, in the County of Cape May, State of New Jersey, as follows:

Section 1. The portion of Ordinance No. 1490, adopted 5/6/2026 and the portion of Ordinance No. 1485, adopted 4/15/2026 and the portion of Ordinance No. 1445, adopted 2/5/2025 and the portion of Ordinance No. 1332, adopted 8/5/2020, that had been codified in the Code of the Borough of Wildwood Crest as Section 79-32.3 Schedule IC of Chapter 79 is hereby amended and supplemented as follows (added language is underlined, deleted language is ~~stricken~~):

Section 2. Schedule IC of Section 79-32.3, entitled restricted parking zones for persons with disabilities, is hereby amended and supplemented as follows (added language is underlined, deleted language is ~~stricken~~):

Section 79-32.3, Schedule IC, restricted parking zones for persons with disabilities.

- B. Only those persons authorized pursuant to the provisions of § 79-7B shall be permitted to park a vehicle between the hours and days specified upon any of the following described locations:

79-32.3 Schedule IC, restricted parking zones in front of residences occupied by persons with disabilities				
Name of Street	Side	Hours	Day	Location
118 W. Wisteria Road	South	All	All	Beginning 286' west of the westerly curbline of New Jersey Avenue and extending to a point 24' west thereof
109 E. Fern Road	North	All	All	Beginning at a point 174' east of the easterly curbline of New Jersey Avenue and extending to a point 25' east thereof

113 E. Columbine Road	North	All	All	Beginning at a point 201' east of the easterly curbline of New Jersey Avenue and extending to a point 23' east thereof

Section 3. The portion of Ordinance No. 1485, adopted 4/15/2026, and the portion of Ordinance No. 1347, adopted 3/31/2021 that had been codified in the Code of the Borough of Wildwood Crest as Schedule ID of Section 79-32.4 is hereby amended and supplemented as follows (added language is underlined, deleted language is ~~stricken~~):

Section 4. Schedule ID of Section 79-32.4, entitled parking of low-speed vehicles and motorcycles, is hereby amended and supplemented as follows (added language is underlined, deleted language is ~~stricken~~):

Section 79-32.4, Schedule ID, parking of low-speed vehicles and motorcycles.

In accordance with the provisions of § 79-8.4, no person shall park a golf cart or motorcycle longer than the time limit specified, subject to the provisions of Chapter 47, Parking Meters, upon any of the following described streets or parts of streets:

79-32.4 Schedule ID, parking of low-speed vehicles and motorcycles only

Section 5. The portion of Ordinance No. 735, adopted 1/9/1991 and the portion of Ordinance No. 1237, adopted 5/25/2016 that had been codified in the Code of the Borough of Wildwood Crest as Schedule IA of Section 79-32.1 is hereby amended and supplemented as follows (added language is underlined, deleted language is ~~stricken~~):

Section 6. Schedule IA of Section 79-32.1, entitled parking restricted at all times, is hereby amended and supplemented as follows (added language is underlined, deleted language is ~~stricken~~):

Section 79-32.1, Schedule IA, parking restricted at all times.

In accordance with the provisions of § 79-3.1, no person shall park a vehicle, other than police vehicles, at any time upon any of the following described streets or parts of streets:

79-32.1 Schedule IA, parking restricted at all times.

Name of Street	Side	Location
<u>Heather Road</u>	<u>North</u>	<u>Beginning from the westerly curbline of Lake Road and extending west to the westerly terminus of Heather Road</u>

Section 7. Portion of Section 79-3, entitled Parking prohibited at all times, is hereby amended and supplemented as follows (added language is underlined, deleted language is ~~stricken~~):

No person shall park a vehicle at any time upon any of the following described streets or parts of streets:

~~G. Parking at the Nesbitt Information Center, 500 block of East Rambler Road, shall consist of four designated parking spaces. Two spaces shall be designated as “20 Minute Parking Nesbitt Center Only.” Two spaces shall be designated as “handicapped parking.”~~

~~H. Parking at the Wildwood Crest Library, 500 block of East Columbine Road, shall consist of two spaces that shall be designated as “handicapped parking.” All other parking spaces shall be designated as “library business only.”~~

Section 8. The remainder of all other sections and subsections of the aforementioned ordinance not specifically amended by this Ordinance shall remain in full force and effect.

Section 9. All other ordinances in conflict with or inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

Section 10. If any portion of this ordinance is adjudged unconstitutional or invalid by a court of competent jurisdiction, such judgment shall not affect or invalidate the remainder of this ordinance, but shall be confined in its effect to the provision directly involved in the controversy in which such judgment shall have been rendered.

Section 11. This ordinance shall become effective twenty (20) days after final passage and advertisement thereof as required by law.
